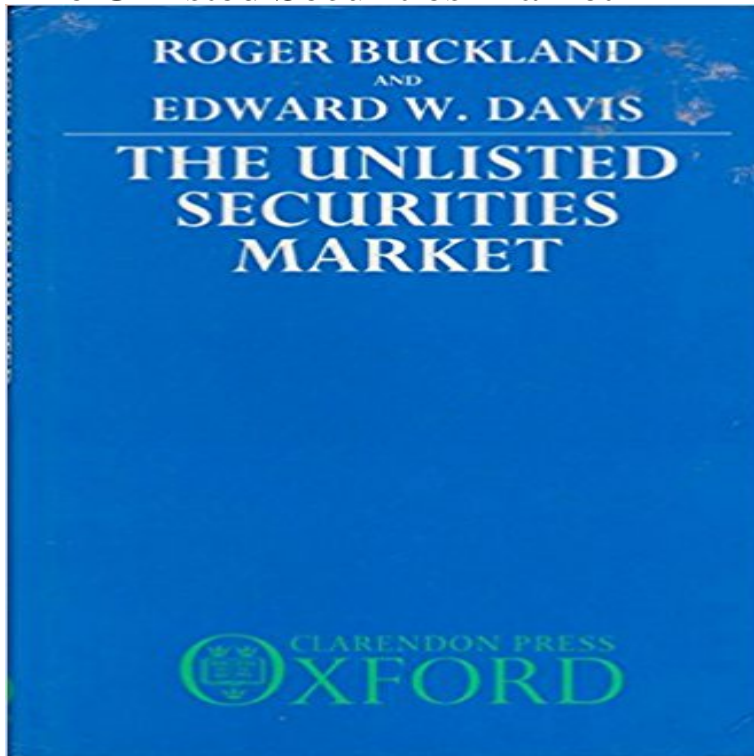


The Unlisted Securities Market
