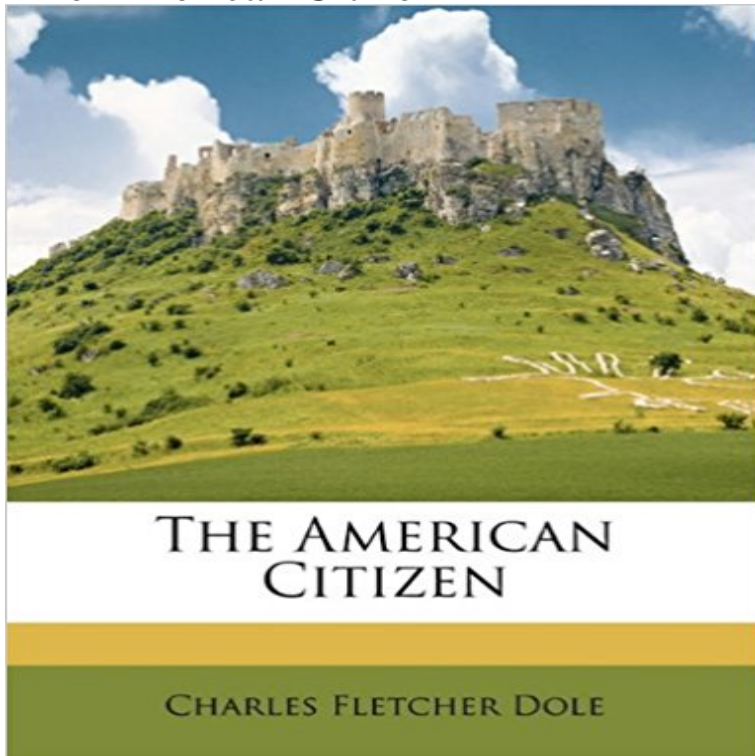


# The American Citizen
