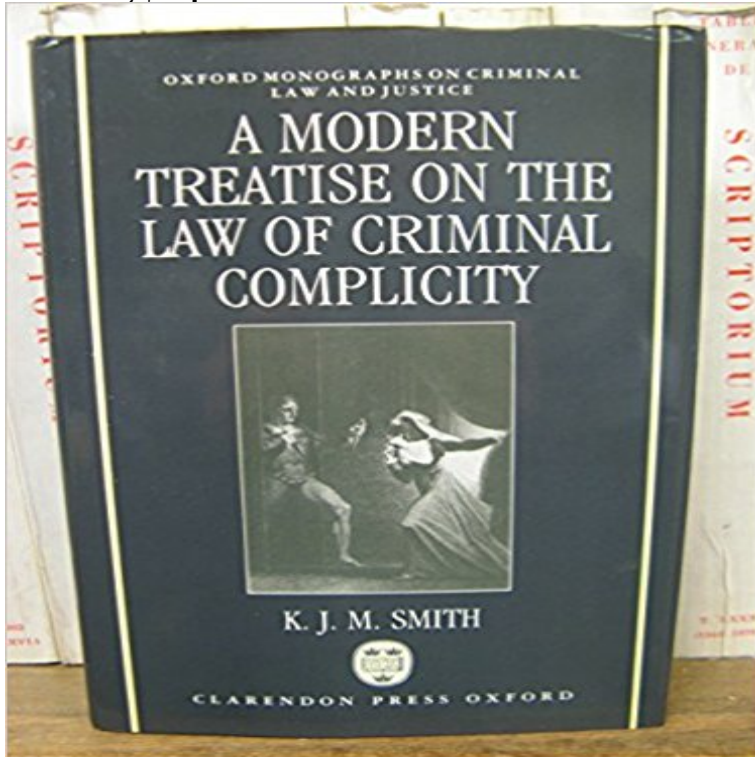


## A Modern Treatise on the Law of Criminal Complicity (Oxford Monographs on Criminal Law and Justice)
