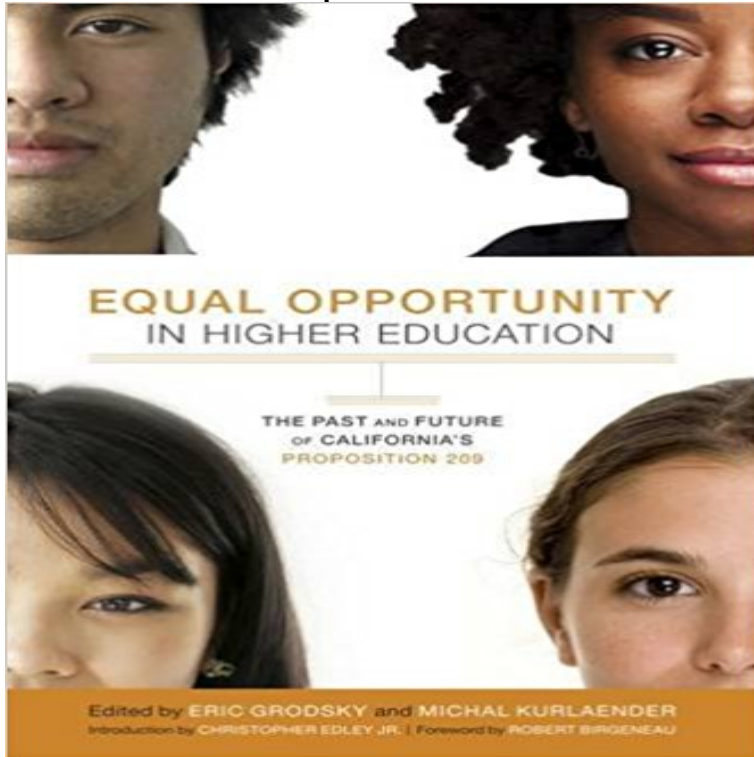


# Equal Opportunity in Higher Education: The Past and Future of California's Proposition 209
