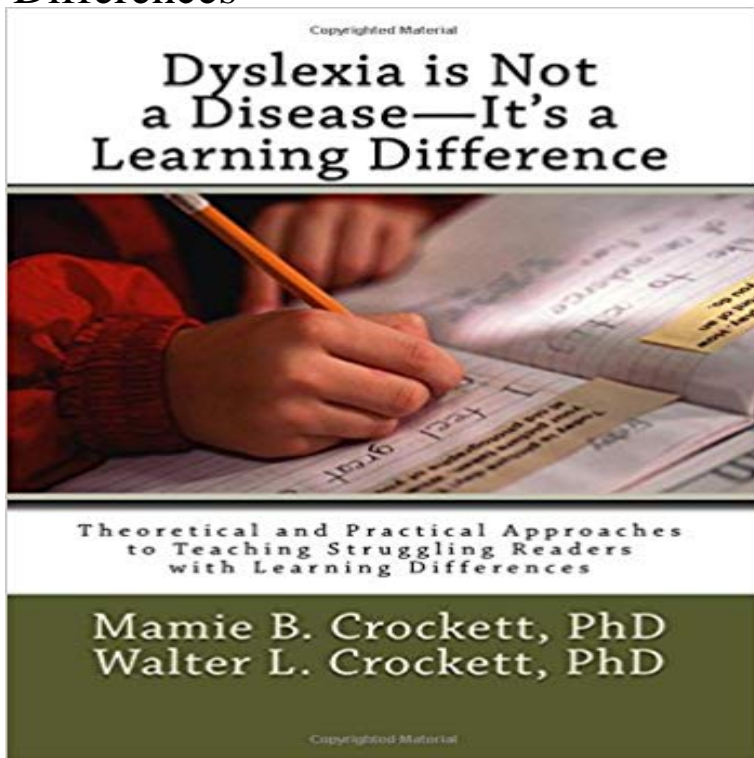


Dyslexia is Not a Disease - Its a Learning Difference: Theoretical and Practical Approaches to Teaching Struggling Readers with Learning Differences
