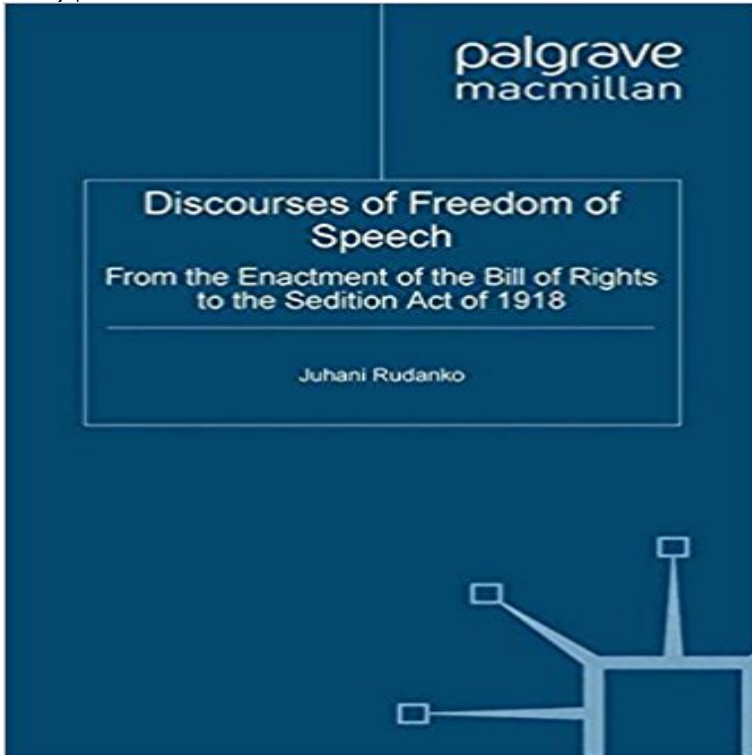


Discourses of Freedom of Speech: From the Enactment of the Bill of Rights to the Sedition Act of 1918
