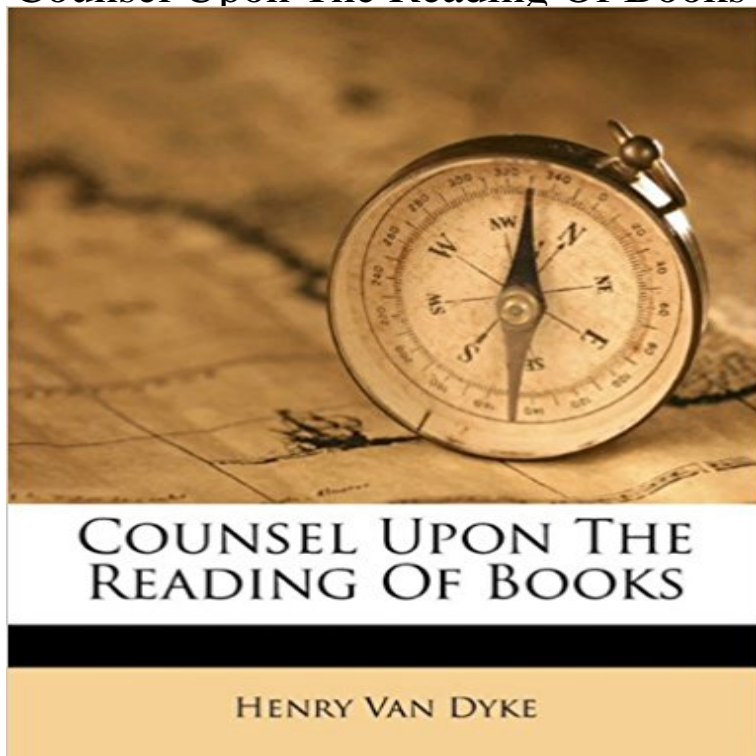


Counsel Upon The Reading Of Books
