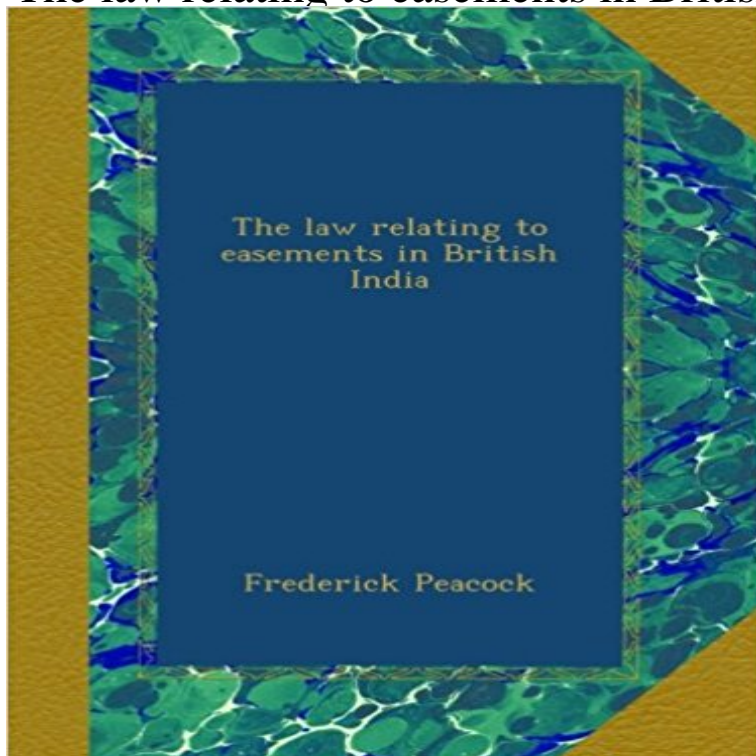


The law relating to easements in British India
