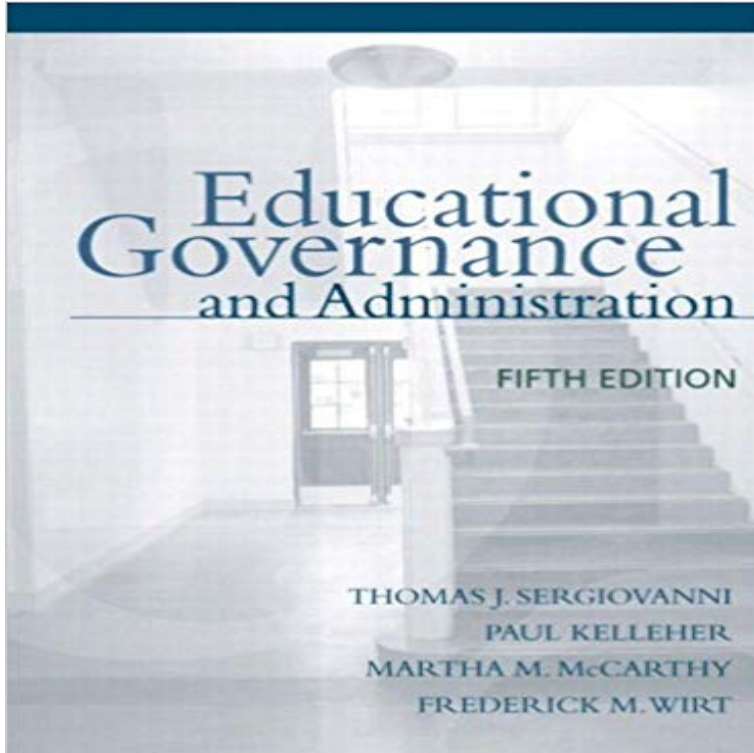


## Educational Governance and Administration (5th Edition)
