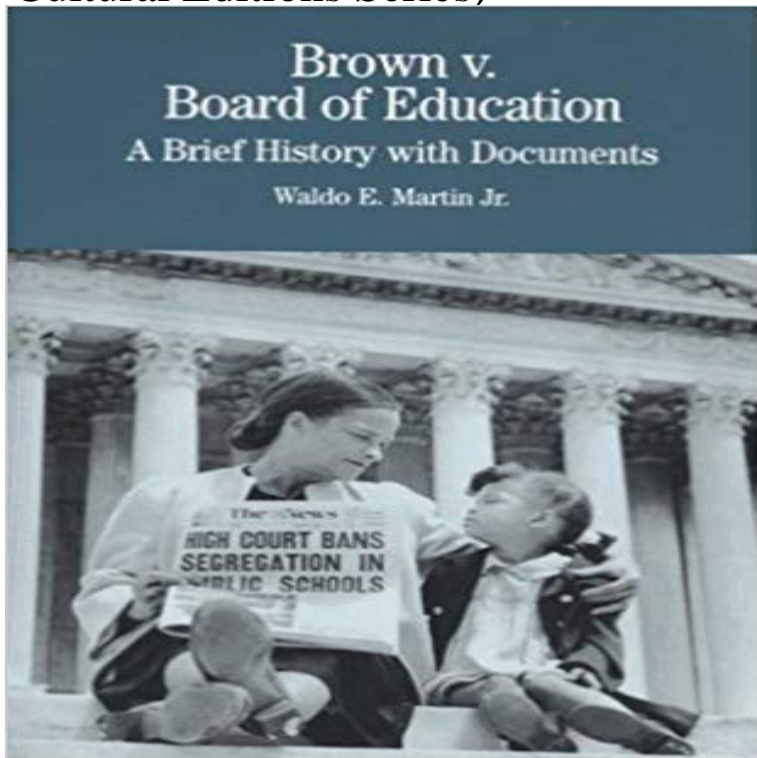


# Brown v. Board of Education: A Brief History with Documents (Bedford Cultural Editions Series)
