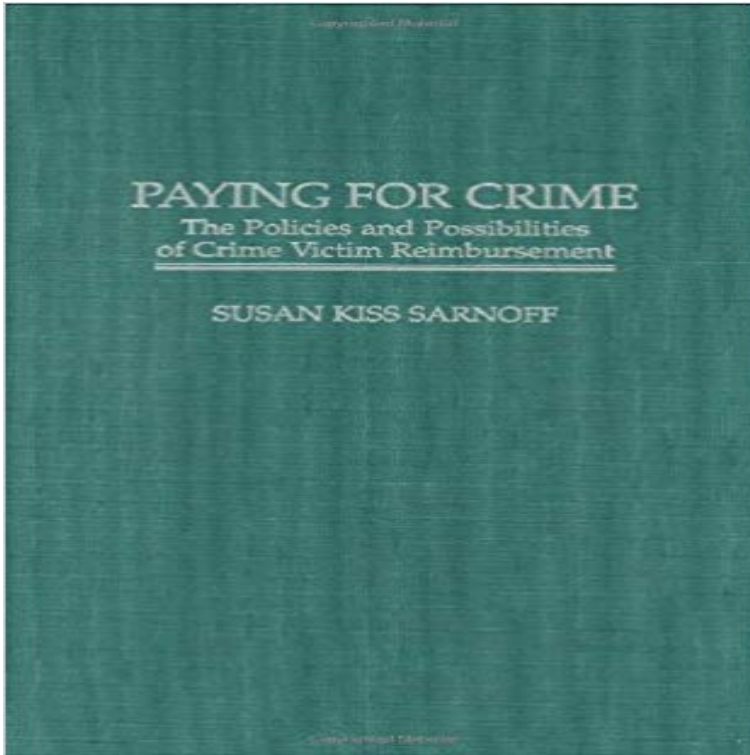


Paying for Crime: The Policies and Possibilities of Crime Victim Reimbursement
