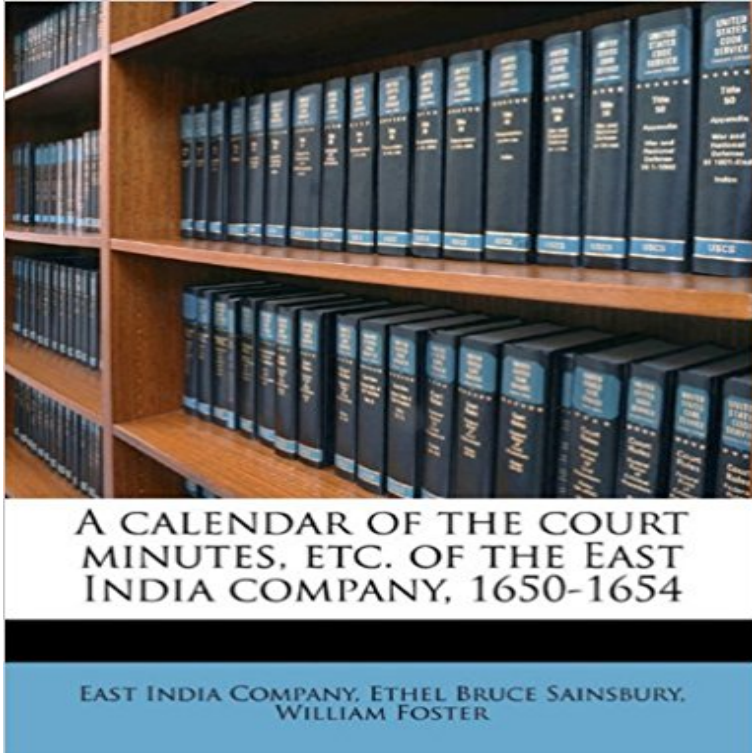


# A calendar of the court minutes, etc. of the East India company, 1650-1654
