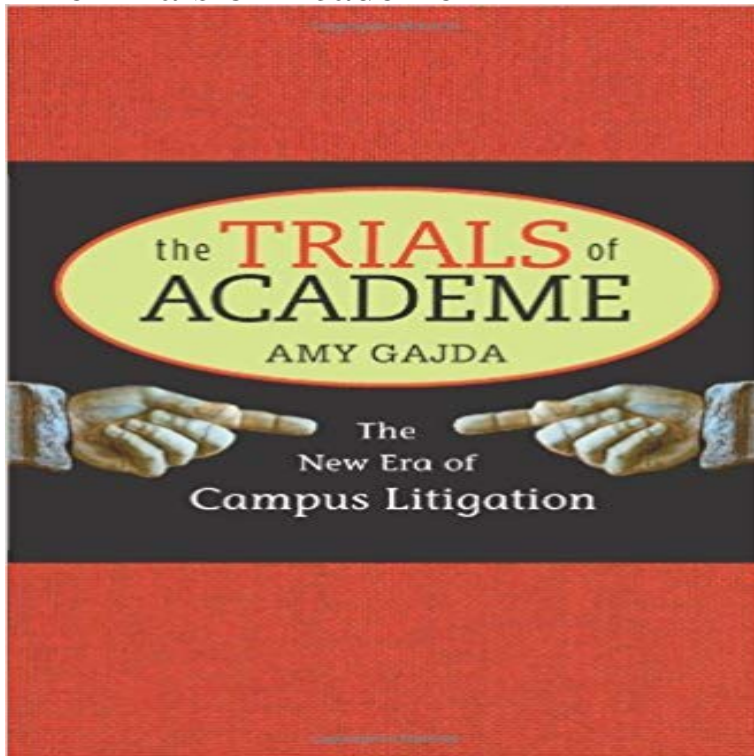


The Trials of Academe
