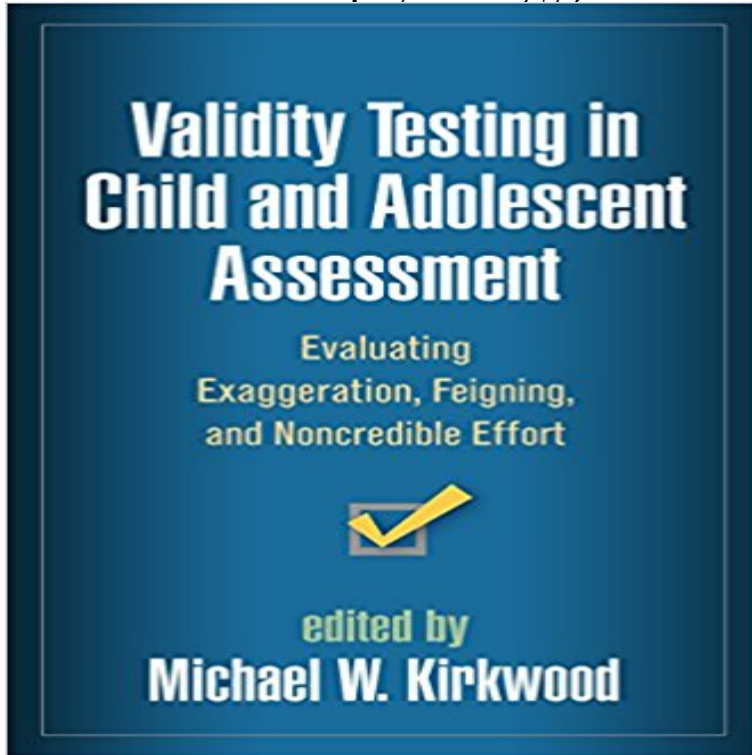


Validity Testing in Child and Adolescent Assessment (Evidence-Based Practice in Neuropsychology)
