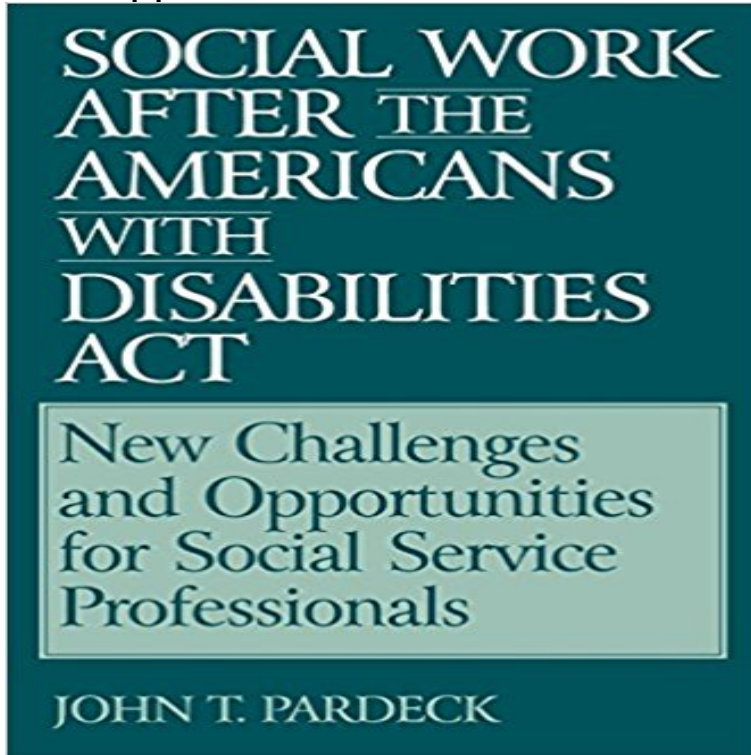


Social Work After the Americans With Disabilities Act: New Challenges and Opportunities for Social Service Professionals
