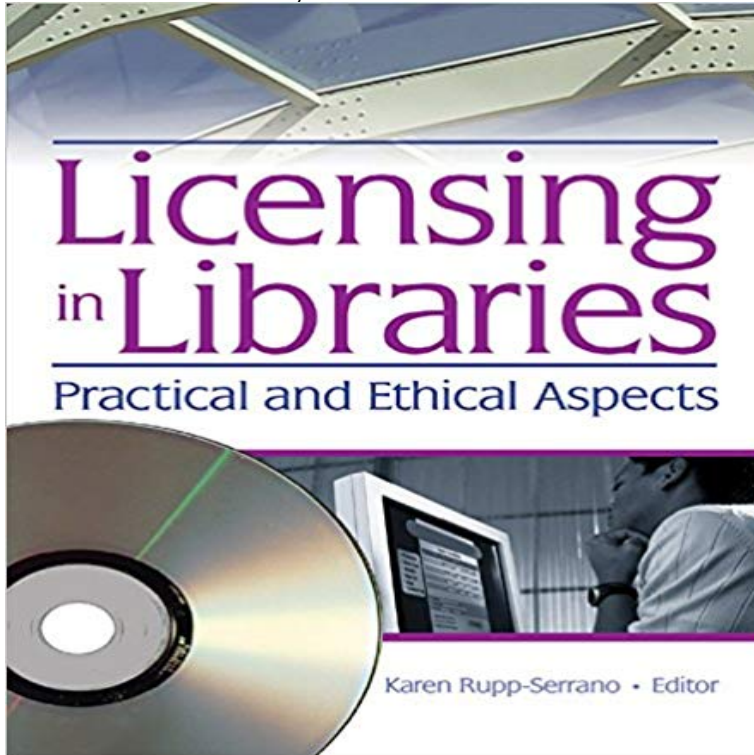


# Licensing in Libraries: Practical and Ethical Aspects (Published Simultaneously as the Journal of Library Administr)
