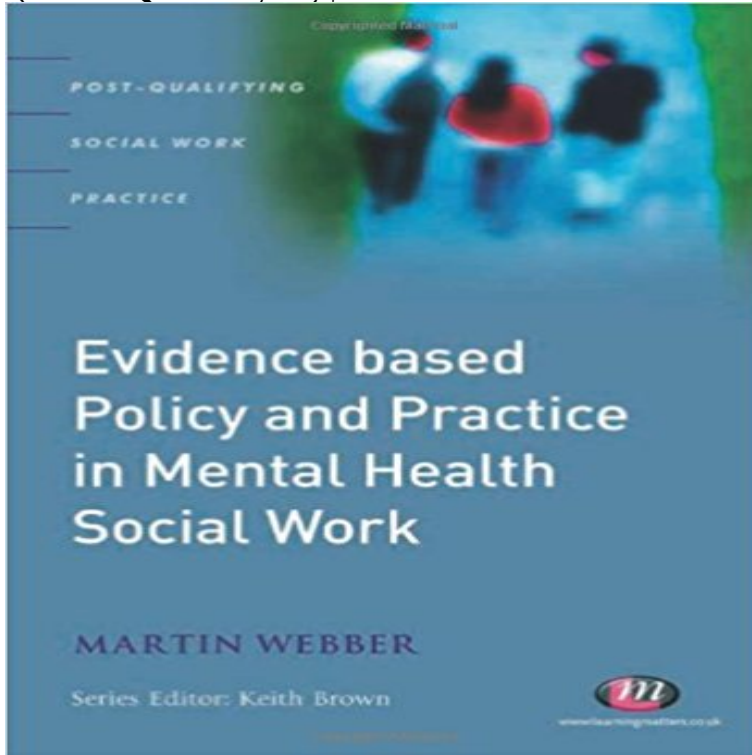


Evidence-based Policy and Practice in Mental Health Social Work (Post-Qualifying Social Work Practice Series)
