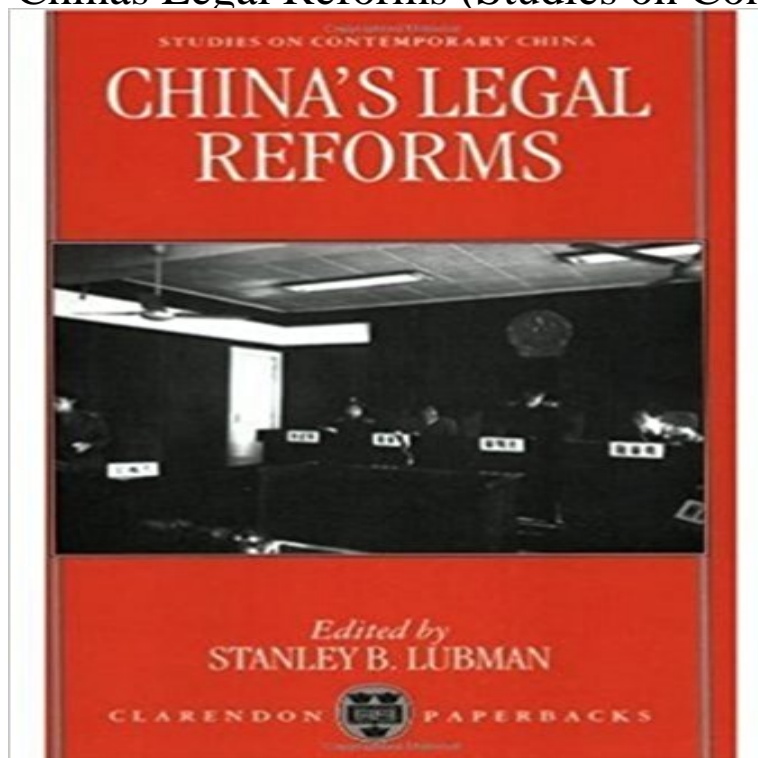


Chinas Legal Reforms (Studies on Contemporary China)
