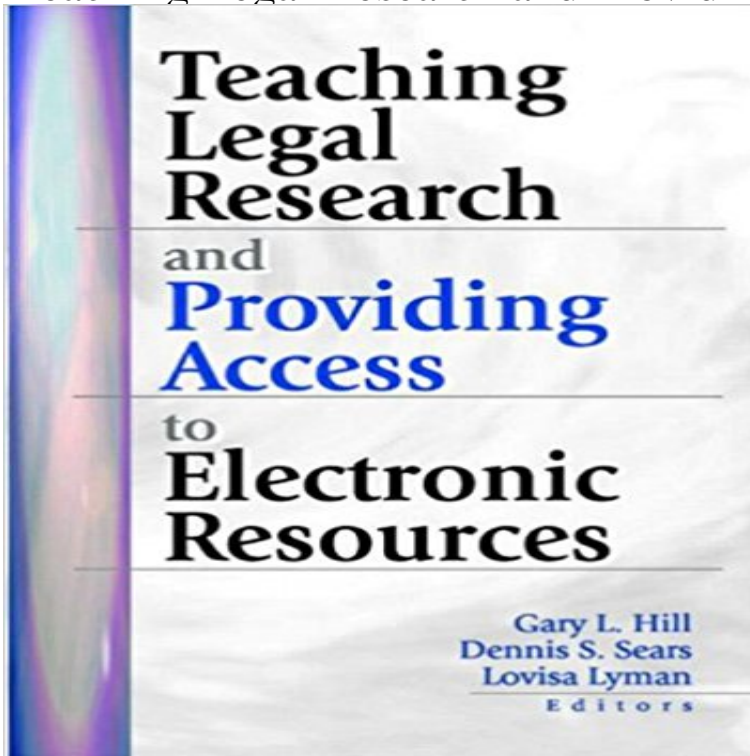


## Teaching Legal Research and Providing Access to Electronic Resources
