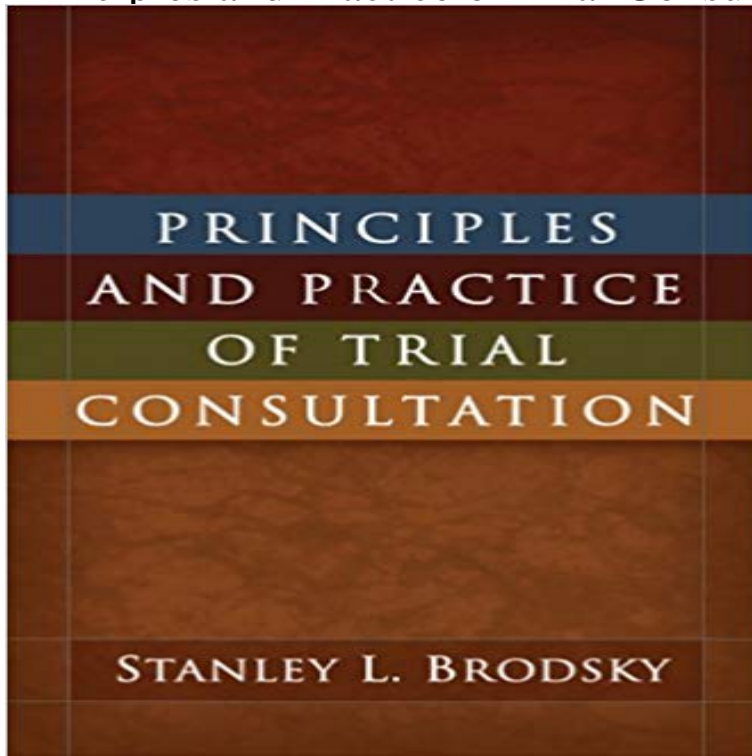


Principles and Practice of Trial Consultation
