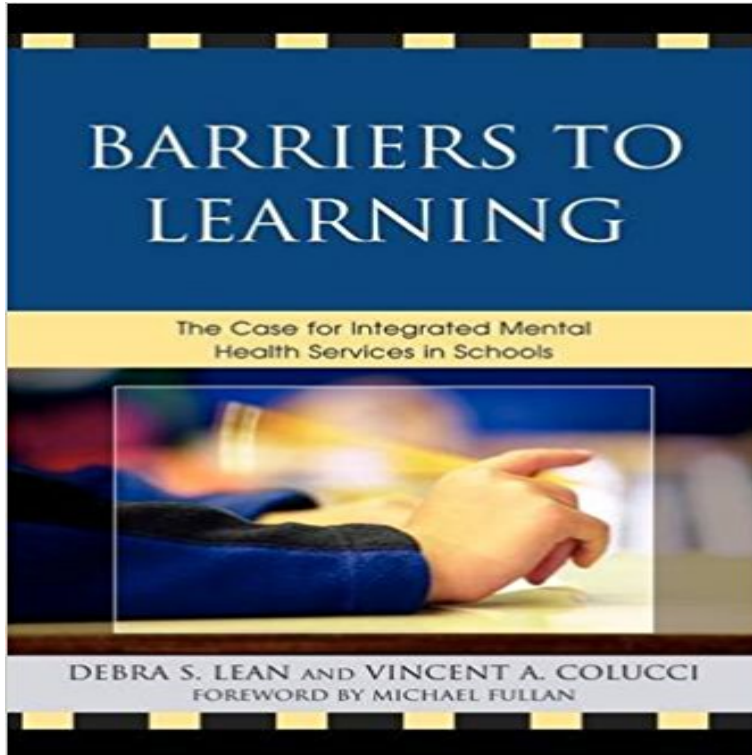


Barriers to Learning: The Case for Integrated Mental Health Services in Schools
