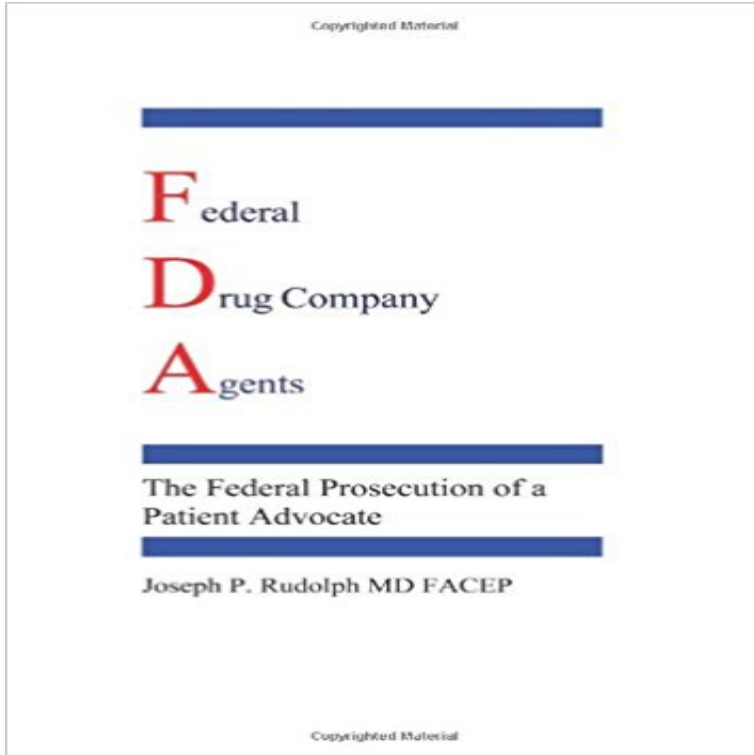


# Federal Drug company Agents: The Federal Prosecution of a Patient Advocate
