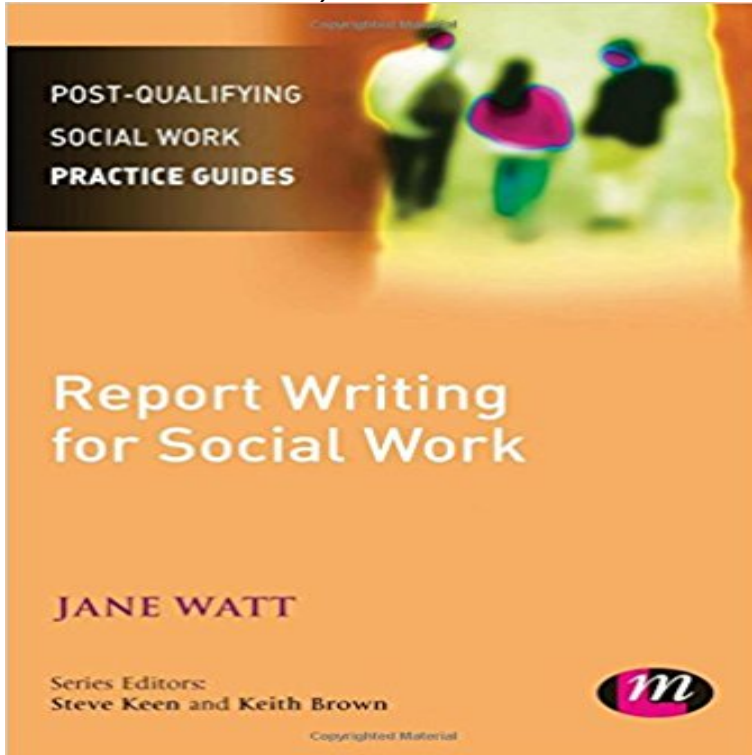


Report Writing for Social Workers (Post-Qualifying Social Work Practice Guides)
